

- 1. Service tubing should always be snaked in the ditch.
- 2. Use a tube or pipe cutter to assure a square end. Make sure pipe is round. On copper tubing, use a rounding tool, if necessary. Surface should be clean and free of nicks.
- 3. Insert stiffeners must be used on all plastic tube except rigid PVC.

4. Stab tube or pipe through the nut and into the socket of the valve or fitting until it bottoms out (Some fittings may or may not have a stop).

- **5.** Tighten the "Ranger" Series nut to the following minimum torques. Over torquing by 5-10 ft-lbs will not affect connection.
- 6. PRESSURE TEST FOR LEAKS BEFORE BACKFILLING
- 7. Use only on cold water services.
